Proposed Roster consultation SNSWLHD Coastal Network Corporate Services – Health and Security Services

Dear Mr Hayes

I am writing to you regarding a proposal to change Rosters at Pambula and South East Regional Hospital (SERH) SNSWLHD within Health and Security Services located under the governance of Coastal Network Corporate Services Manager.

This is a proposal. No decision has been made. I am advising staff of the proposal and inviting feedback. I will consider all feedback and will then advise of the decision made.

The intention of this proposal is to change current roster patterns at SERH and Pambula to be fair and equitable and in accordance with Public Health State Award and imbed NSW Health Rostering Best Practice.

A summary of the impact of this proposal includes:

- Changes to;
 - Propose new roster for Pambula District Hospital
 - Consult on drafting a new roster for South East Regional Hospital
 - Propose innovative change of a 12 hour shift at Pambula seven (7) days a week. This includes consideration to flexing up and down Health and Security staffing based on patient care and facility safety needs as described in Protecting People and Property NSW Health Policy and Standards for Security Risk Management in NSW Health Agencies.
 - Proposed operational hours for Pambula 12 hour roster 0930 to 2200 subject to change.

I have enclosed a copy of the proposed Roster that is currently under consultation with Health and Security Assistants being rostered at Pambula District Hospital

I have also enclosed a copy of the communication sent to all staff.

If any staff members are affected by these proposed changes, they will be managed in line with NSW Health Policy Directive: Managing Excess Staff of the NSW Health Service.
