Re: Establishment of a Staff Consultative Committee - Oral Health Services, WSLHD

I write to advise you of the proposed establishment of a Staff Consultative Committee for the Oral Health Service across Western Sydney Local Health District (WSLHD).

The Oral Health Service provides general dental and dental surgery services to the eligible population of WSLHD. It is also a state-wide specialist oral health service provider for NSW. The service is one of two major teaching facilities for the faculty of Dentistry of the University of Sydney and employs approximately 350 FTE between the Westmead Centre for Oral Health and Mt. Druitt Oral Health Centre. The majority of these employees are covered by Awards with coverage of the Health Services Union (HSU).
