I am writing to advise and provide you with a copy of the restructure plan for the proposed changes within Illawarra Shoalhaven Local Health District (ISLHD) associated with the relocation of the three Wards, the Day Rehabilitation Service, and other support services from Port Kembla District Hospital (PKDH) to Bulli Hospital and Aged Care Centre (BHACC), which has the potential to affect staff covered by your union.
