### **Current and Upcoming works**

#### PLR Update - Andrew peacock

- Works in final 3 to 5 weeks delays in obtaining asphalt which is impacting project
- Finishing works under way for footpaths and landscaping
- Intersection of Bridge Road (last bit of Hainsworth Street detour) will be open in 2 weeks
- 3<sup>rd</sup>/4<sup>th</sup> weekend in April returning Hainsworth Street to two-way traffic and turning on lights at intersection, including roundabout towards Park Road
- Undertaking review process for signage as the signage is over 2 years old and may not be relevant anymore
- Rail grinder activity rail grinder will be coming through site to make sure surface of rail is clean
  and free of rust. Will be a noisy procedure and required to be done through the day. Traffic
  management and areas will be reopened as they are completed. There will be periods of time
  with temporary traffic control.
- Bill raised concerns about how loud/long the grinder will be. Andrew said that the grinder moves
  at walking pace and noise is equivalent to 80 decibels. A disruption notice will be provided

### **PLR Update - Operator**

- · Preparing to move in following completion of infrastructure
- Getting ready to start installing power stations
- First 4 light rail vehicles are complete and undergoing testing with next 4 on assembly line being assembled. Testing is not being conducted on site at Cumberland.
- Production of light rail vehicles remains on track and testing going ahead as planned and to date have not found any major issues.
- Testing on Cumberland campus will be towards end of process and is to be determined. Not expected to be this calendar year.

#### **Cumberland redevelopment**

- PUGs recommenced
- EOI inviting people to participate in model of care development process has been circulated and being emphasised in staff forum and still accepting late submissions.
- Office accommodation process meeting scheduled next week
- Still awaiting announcement about project
- Fran raised concern about walls in B22 not being strong enough and can we look at using a harder material when doing new build
- Matt confirmed that there is a defect with the walls. Wall is a single sheet of product instead of double. This is an issue and there are two parts, rectification and design solution and there will be a list of issues and lessons learned.





#### **Blacktown**

- It was noted that the Mental Health Minister visited B22 this morning and was very impressed on the recovery focus of the unit.
- B22 occupied on 22 February. Minor adjustments are required.
- Waiting on HI to award negotiations on contract for Bunya and first stage will be demolition. Some assets have been repurposed.
- There have been some issues with the automatic dispensing device for medicines. Nurses had
  not been appropriately trained. Will need to consider Forensic unit and Westmead Hospital and
  be prepared.
- Fran said there is some reluctance in providing fingerprints for the fingerprint device and asked if there is a bypass if staff do not want to provide their fingerprint is there a policy on protection of staff information? How is the information stored/what is the security?
- May need to follow up with Blacktown Pharmacy.
- Wade said there is data management and security that goes with these systems. He is aware of two senior nurses that have looked at the systems and he will try to locate the information and provide to Fran.
- Issue with alarm sounding when doors are not closed properly. Alarm is very loud and staff are complaining.
- Matt said that the alarm was to remain enabled for a short period of time as a reminder while staff
  were transitioning. Alarm will need to be disabled or replaced as the volume cannot be adjusted.
- Fran said that she believes the nurses window issue had been rectified. There was a gap in the window which allowed someone to spit or put something through.
- Bill said the issue with the curved glass has been fixed. The gap was to encourage open discussion with patients and enable communication.
- Bill suggested we need to review and see how it is going and discuss further with Blacktown nursing staff.

ACTION: Wade will try to locate information about fingerprint device and provide to Fran.
