Dear Mr Hayes

I write to you regarding proposed changes to the structure of the District Revenue Team within South Western Sydney Local Health District (SWSLHD) which has the potential to directly affect your members.

As part of the Revenue Optimisation project, a review of all roles and functions within District and Facility Revenue teams is occurring. The review is aimed at ensuring the teams are enabled to deliver a person-centred, adaptable service which can maximise revenue opportunities to support a sustainable health system. District Finance has identified that the SWSLHD Revenue Manager, Health Manager Level 3, position is no longer supporting the current needs of the revenue function.

The change has been greatly influenced by the recent availability of various Ministry of Health (MOH) and eHealth self-serve tools, reports and dashboards which have shifted focus away from in-house push reporting to that of support, partnering and training across SWSLHD. An additional change needing to be undertaken is the integration of activity and costing information into finance and revenue tools to enable greater organisation wide decision making. A more effective structure has been proposed to better support the current business needs and allow greater financial business partnering across the District.

The proposed changes includes the deletion of the Revenue Manager, Health Manager Level 3, position and the creation of the District Director Revenue, Health Manager Level 5 role. The role will provide more effective leadership to better support the strategic direction of this crucial financial element of the organisation. The detailed Position Description for the District Director Revenue role is currently being finalised.

There will also be a change in reporting lines for two positions as demonstrated in the enclosed proposed organisational chart.

We anticipate that the changes will have a positive outcome for District Revenue team and service. It is anticipated that the proposed changes will be implemented in **Monday**, **22 May 2023**

To move forward with the proposed changed we are scheduling a meeting with relevant staff to discuss the proposed changes and provide an opportunity for feedback and comments to be considered. We have scheduled a meeting on **Friday**, **5 May 2023**, at the Ground Floor meeting


