**Financial disclosures as required under the Rules of the
Health Services Union NSW**

**Rule 41; DISCLOSURE BY OFFICERS OF REMUNERATION AND
NON-CASH BENEFITS**

41(c) The Union Committee shall disclose to the members of the Union:

(i) the identity of each officer of the Union who receives remuneration from the Union in connection with their holding of office during the disclosure period, and

(iii) for those officers:
