Far West LHD Organisational Restructure – Mental Health Drug and Alcohol

I would like to advise that the Far West Local Health District is undertaking an organisational restructure within its Mental Health Drug and Alcohol directorate (MHDA).

Currently, the MHDA cost centres reporting lines are distributed throughout the Far West LHD districts and directorates. It is proposed that all MHDA cost centres and workforce staff should now report to the Director MHDA. Specifically, this change will impact the following cost centres / teams:-

- 1) CC830540 Broken Hill MHDA Community Team
- 2) CC830271 CAMHS
- 3) CC830329 Dareton MHDA Community Team
- 4) CC830187 Mental Health Inpatient Unit

This change in structure will enhance a more cohesive strategic and operational approach to the District's MHDA services and provide a more streamlined service. Please find attached the current and proposed organisational charts for reference.

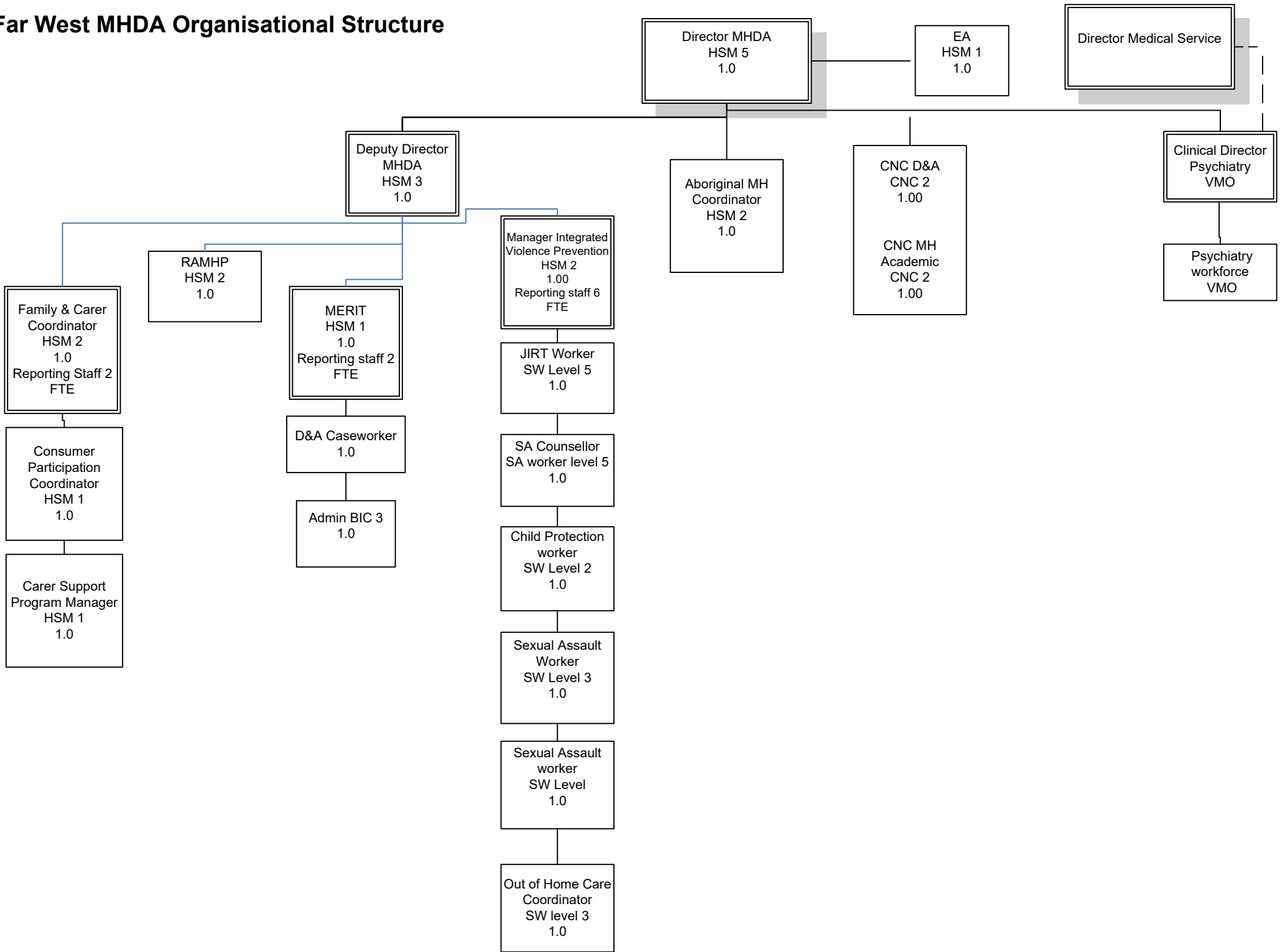
