

## RPA Environmental Services Dispute Update

Dear Member,

Your organiser and two Sub Branch delegates attended another meeting with management on Tuesday 10 September to further advocate members' concerns relating to poor workplace culture within the Environmental Services Department at RPA. Previously, the HSU understood that we had an agreement with management which would allow you and other members an opportunity to raise grievances.

Management had agreed to investigate these allegations not through the RPA HR Department but by using another HR Department within the SLHD. During the past few months management has attempted to investigate only one serious allegation, although this has involved 6 separate incidents. However, there are many other complaints and concerns which have not been addressed.

It is clear to us that RPA Management is trying to avoid fulfilling their agreement, while most members' concerns still remain unaddressed and unresolved. We will continue to push management to institute the process they had already agreed to and for your concerns to be heard, addressed and resolved. The HSU and your delegates want your support in moving this forward. We will be holding meetings soon and you will be notified soon closer to the exact date.
